Notification

Whereas the State Election Commission vide Notification No.SEC:13-90/2016-V-1755-1919, dated 24th May, 2025 issued programme for delimitation of wards in respect of 73 Municipal Bodies in the State and as per the programme 16.06.2025 was the last date fixed for disposal of objections by the Deputy Commissioners;

And whereas the Commission has received a request from Deputy Commissioner, Hamirpur vide Letter No. DCH/UDB/Election/2025-342, dated 16th June, 2025 wherein it is mentioned that the district has received high volume of objections and these objections include population disparities & socio administrative contiguity and requested for extension of time;

And whereas the Deputy Commissioner, Hamirpur vide Letter No. DCH/UDB/Election/2025-390, dated 17th June, 2025 has informed this Commission that all the objections have been disposed of on 17.06.2025;

And whereas, the matter was placed before the Commission and the Commission is of the considered view that in a larger public interest, the time fixed for filing and disposal of appeals may be extended by one day in accordance with statutory provisions;

Therefore, the State Election Commission in exercise of the powers vested in it under Article 243ZA of the Constitution of India, Section 9 and 10 of the H.P. Municipal Corporation Act, 1994, Section 11 and 281 of the H.P. Municipal Act, 1994 read with Rules 6 and 10 of the H.P. Municipal Corporation Election Rules, 2012 and the H.P. Municipal Election Rules, 2015 and all plenary powers available to it in this behalf, hereby directs that delimitation of wards in respect of Municipal Corporation, Hamirpur, Municipal Council Nadaun, Nagar Panchayat Barsar and Nagar Panchayat Bhoranj of district Hamirpur shall be completed in accordance with the following revised schedule:-
