## **Notification**

Whereas the State Election Commission vide Notification No.SEC:13-90/2016-V-1755-1919, dated 24<sup>th</sup> May, 2025 issued programme for delimitation of wards in respect of 73 Municipal Bodies in the State;

And whereas the Commission received a request from Deputy Commissioner, Mandi, Solan, Una and Kangra wherein it is mentioned that the objections / suggestions received in respect of Municipal Corporation Mandi, Baddi, Una, Dharamshala and Palampur pertain to the geographical, demographic and administrative configuration of the proposed wards and these issues necessitate thorough field verification which requires co-ordinated efforts from multiple Departments. A detailed ground level inspection and application of mind is needed for disposal of these objections and the Commission has been requested to extend the time fixed for disposal of objections;

And whereas, the request of the districts was placed before the Commission and the Commission is of the considered view that in the light of the reasons advanced by the Deputy Commissioners and in a larger public interest, the request of the districts to extend the time fixed for disposal of objections may be accepted to enable them to carry out the ongoing delimitation exercise in a proper manner;

Therefore, the State Election Commission in exercise of the powers vested in it under Article 243ZA of the Constitution of India, Section 9 and 10 of the H.P. Municipal Corporation Act, 1994 read with Rules 6 and 10 of the H.P. Municipal Corporation Election Rules, 2012 and all plenary powers available to it in this behalf, hereby directs that delimitation of wards in respect of Municipal Corporations Mandi, Baddi, Una, Dharamshala and Palampur shall be completed in accordance with the following revised schedule:-
