**ADDENDUM**

In continuation to this Department's Notification of even number dated 28th May, 2016 (declaring 17<sup>th</sup> June, 2016 & 19<sup>th</sup> June, 2016 as public holiday in District Lahaul-Spiti & Chamba, Himachal Pradesh on account of general election of Panchayati Raj Institutions (in the areas of those PRIs, where the elections are scheduled to be held) on the respective dates (in case poll is held), **the Governor, Himachal Pradesh is also pleased to declare 17<sup>th</sup> June, 2016 as public holiday on account of election of casual vacancies of Panchayati Raj Institutions located in different Districts of the State where office bearers could not be elected for some reasons during the general election for PRIs held in January, 2016 (in the areas of those PRIs, where the elections are scheduled to be held), in case poll is held.** All Government Offices, Boards, Corporations, Educational Institutions and Industrial Establishments situated in the above areas where elections are scheduled under Industrial Disputes Act and shops will remain closed on the said date in such areas. This will also be a paid holiday to daily wage employees and also within the meaning of Section 25 of Negotiable Instrument Act 1881.

It is, however, clarified that special casual leave may be given to those employees who are working in different places in the State but have a right to vote in respective Panchayati Raj Institutions, on the production of certificate from the concerned Presiding Officer that the employee has actually cast his/ her vote.
