#### Office Order

Whereas State Election Commission has received various references and complaints from the District Election Officers that name of certain electors appearing in the Working Rolls/Draft Electoral Roll and added in the Electoral roll after the disposal of claims and objections have not been shifted/appeared in to the final Electoral roll due to technical error;

And whereas, the State Election Commission is of the considered view that in the interest of larger participation and in order to provide right to franchise to those electors whose name were available in the draft electoral Roll and were not transferred to the final Electoral Roll, it is just appropriate to correct the Electoral Rolls .

Now , therefore, State Election Commission in exercise of powers vested in it under Article 243 K, ZA of the Constitution of India, Section 160 of the Himachal Pradesh Panchayati Raj Act, 1994 read with Rule 3 of Himachal Pradesh Panchayati Raj Election Rules, 1994, Section 281 of the Himachal Pradesh Municipal Act, 1994 read with Rule 14 of the Himachal Pradesh Municipal Election Rule 2015 and all other powers enabling it in this behalf hereby authorizes all the District Election Officers, Panchayat / Municipalities-cum-Deputy Commissioners to include the names of such electors by adding a supplementary list to the main electoral roll subject to the condition that names of the electors were available in the Draft Electoral Roll .

Further, the District Election officer Panchayat/Municipalities-cum-Deputy Commissioners are also authorized to insert corrections not of substantial characters in the Electoral Roll on an application by the elector through supplementary list. All inclusions /corrections shall be done on or before the last date fixed for the filing of nominations latest by 3 O'clock.
