NOTIFICATION

In exercise of the powers vested in it under Article 243-ZA of the Constitution of India, Section 281 of the Himachal Pradesh Municipal Act, 1994 read with Rule 35 of the Himachal Pradesh Municipal (Election) Rules, 2015, the State Election Commission Himachal Pradesh hereby notifies the Election Programme for the conduct of by-elections to vacancies in Ward No. 6 of Municipal Council Santokhgarh, District Una and Ward No. 6 & 7 of Nagar Panchayat Karsog District Mandi as under:-

1	Nomination papers shall be presented:	On 7th, 8th and 11th September, 2017 (between 11 am to 3 pm). Nomination papers shall be filed at specified places and before the Officers appointed by the Returning Officer.
2	The nomination papers shall be scrutinized:	On 12th September, 2017 (From 10.00 am onwards)
3	A candidate may withdraw candidature:	On 14th September, 2017 (Between 10.00 am to 3.00 p.m.)
4	List of contesting candidates showing the name of symbol allotted to them shall be prepared and affixed:	On 14th September, 2017 immediately after the time of withdrawal is over.
5	List of Polling stations shall be published:	On or before 7th September, 2017
6	The Poll, if necessary, shall be held from 8 AM to 4 PM:	On 24th September, 2017.

7	Counting of votes, in the event of Poll, shall be done:	The counting of votes shall be taken up immediately after the close of the poll at the Municipal Headquarters.
8	The results of election shall be declared.	The results of the election shall be declared immediately after the counting is over.

The process of election shall be completed by 25 September, 2017.

The electoral rolls earlier updated shall be used for the conduct of these elections. However, any eligible elector can apply for inclusion of his/her name in the electoral rolls not later than eight days before last date fixed for filing of nomination papers. A supplementary list shall be prepared and added to the main electoral rolls. The electors included in the supplementary list shall be given serial number next to the last serial number of the already finalised and published electoral rolls. Even if, there is no inclusion or correction in the electoral rolls, 'Nil' inclusion or correction as the case may be shall be shown and attached to the main electoral rolls.
