| 6 | The Poll, if necessary, shall be held from 7 AM to 3 PM: | On 29th January, 2017. |
| 7 | Counting of votes, in the event of Poll, shall be done: | The counting of votes shall be taken up immediately after the close of the poll at the Municipal Headquarters. |
| 8 | The results of election shall be declared. | The results of the election shall be declared immediately after the counting is over. |
