NOTIFICATION

In exercise of the powers vested in it under Article 243 ZA of the Constitution of India, Section 9 (1) of the Himachal Pradesh Municipal Corporation Act, 1994 read with Rule 6(1) and 10 of the Himachal Pradesh Municipal Corporation Election Rules, 2012, the State Election Commission, Himachal Pradesh hereby directs that the delimitation and reservation of wards in respect Municipal Corporation Dharamshala shall be undertaken as per following programme:

Sr. No.	Process	Period
1.	Publication of Draft Proposal of the delimitation of wards	16.11.2015
2.	Filing of objections on the draft proposal by the residents of concerned Municipal areas before the Deputy Commissioner Kangra	17.11.2015 to 26.11.2015
3.	Disposal of suggestions or objections by the respective Deputy Commissioner	Within ten days from the filing of objections
4.	Filing of Appeals by the aggrieved person before the Divisional Commissioner Kangra	Within ten days from the disposal of objections
5.	Disposal of Appeals by the Divisional Commissioner	Within ten days from the filing of Appeals
6.	Final orders of Delimitation of Wards by concerned Deputy Commissioner	On or before 28 th December, 2015
7.	Reservation of Wards for members	Upto 31 st December, 2015
8.	Report of final reservation orders in respect of members to the State Election Commission by the Government	On or before 2 nd January, 2016.

If no objection is received or no appeal is filed, the Deputy Commissioner may issue final delimitation orders so as to save the time and start working


on reservation of wards in accordance with the provisions enshrined under HP Municipal Corporation Act, 1994 and HP Municipal Corporation Election Rules, 2012.

As soon as the reservation of wards is finalized, the Deputy Commissioner, will ensure that it is delivered to the Government immediately so that the Government could* provide the copy of final reservation orders to the State Election Commission under Rule 13 of the ibid Rules.
