NOTIFICATION

In exercise of the powers vested in it under Article 243-ZA of the Constitution of India, Section 281 of the Himachal Pradesh Municipal Act, 1994 read with Rule 35 of the Himachal Pradesh Municipal Election Rules, 2015, the State Election Commission Pradesh hereby notifies the Election Programme for the conduct of general elections to Municipal Committees in Himachal Pradesh as under :-

1	Nomination papers shall be presented;	On 26 th , 28 th , and 29 th December, 2015 (between 11 am to 3 pm). Nomination papers shall be filed at designated places and before the Officers appointed by the Returning Officer for the purpose.
2	The nomination papers shall be scrutinized;	On 30 th December, 2015 (From 10.00 am onwards)
3	A candidate may withdraw his candidature;	On 1st January, 2016 (Between 10.00 am to 3.00 p.m.)
4	The list of contesting candidates showing the name of symbols allotted to them immediately after the time of withdrawal is over shall be prepared and affixed;	On 1st January, 2016 immediately after the time of withdrawal is over.
5	The list of Polling stations shall be pasted ;	On or before 26 th Dec, 2015.
6	The Poll, if necessary, shall be held from 7 AM to 3 PM	On 10 th January, 2016
7	Counting of votes, in the event of poll, shall be done	The Counting of votes shall be taken up immediately after the close of the poll at the Municipal Headquarters


Note: The process of election shall be completed by 11th January, 2016.
