7	Counting of votes, in the event of Poll, shall be done;	(i) The counting of votes for the Ward Members, Up-Pradhan and Pradhan of Gram Panchayats shall be taken up immediately after the close of the poll at the Gram Panchayats Headquarters. (ii)The counting of votes for the members of Panchayat Samiti and Zila Parishad shall be taken up on 7th January, 2016 at 8.30 AM. at respective Block Headquarters. The counting for a constituency once started shall continue until it is completed.
8.	The results of election shall be declared.	The results of the election of Member, Up-Pradhan & Pradhan of Gram Panchayat shall be declared immediately after the counting is over. The result of election of Members of Panchayat Samiti and Zila Parishad shall be declared on the day of counting at the Block Headquarters immediately after the counting process is over. The result of election to Zila Parishad shall be declared in accordance with the provisions contained in rule 75(vi) of the Himachal Pradesh Panchayati Raj (Election) Rules, 1994.

Note: The process of election shall be completed by 8th January, 2016.
