In exercise of the powers vested in it under Article 243-ZA of the Constitution of India, Section 9 of the Himachal Pradesh Municipal Corporation Act, 1994 read with Rule 33 of the Himachal Pradesh Municipal Corporation Election Rules, 2012, the State Election Commission Himachal Pradesh hereby notifies the Election Programme for the conduct of by-elections to Ward No. 24 Sangti (Reserved for women) of Municipal Corporation Shimla as under :-

1	The list of Polling stations shall be pasted ;	On or before 27th December, 2018.
2	The nomination papers shall be presented;	On 27th, 28th and 29th December, 2018 (between 11.00 am to 3.00 pm). Nomination papers shall be filed at designated places and before the Officers appointed by the Returning Officer for the purpose.
3	The nomination papers shall be scrutinized;	On 31st December, 2018 (From 10.00 am onwards)
4	A candidate may withdraw his candidature;	On 2nd January, 2019 (Before 3.00 p.m.)
5	The list of contesting candidates alongwith their photograph showing the name of symbol allotted to them immediately after the time of withdrawal is over shall be prepared and affixed;	On 2nd January, 2019 Immediately after the time of withdrawal is over.
6	The Poll, if necessary, shall be held from 8.00 AM to 4.00 PM	On 12th January, 2019
7	The counting of votes, in the event of poll, shall be done	On the same day immediately after polling. The counting shall be held at District Headquarters Shimla.
8	The result of the Election Shall be declared	Immediately after the counting is over

Note: **The process of election shall be completed by 14th January, 2019.**
