4	The list of contesting candidates showing the name of symbols allotted to them immediately after the time of withdrawal is over shall be prepared and affixed;	On Ist January, 2016 immediately after the time of withdrawal is over.
5	The list of Polling stations shall be pasted:	On or before 26th Dec, 2015.
6	The Poll, if necessary, shall be held from 7 AM to	× ×
7	Counting of votes, in the event of poll, shall be done	The Counting of votes shall be taken up immediately after the close of the poll at the Municipal Headquarters

Note: The process of election shall be completed by 11th January, 2016.
