Consequent upon the orders of the Hon'ble High Court of Himachal Pradesh passed while disposing of the CWP No.975 of 2017 titled as Raju Thakur versus State Election Commission and others and in exercise of the powers vested in it under Article 243-ZA of the Constitution of India, Section 9 of the Himachal Pradesh Municipal Corporation Act, 1994 read with Rule 33 of the Himachal Pradesh Municipal Corporation Election Rules, 2012, the State Election Commission Himachal Pradesh hereby notifies the Election Programme for the conduct of general elections to Municipal Corporation Shimla as under :-


1	Nomination papers shall be presented;	On 2nd, 3rd and 5th June, 2017 (between 11.00 am to 3.00 pm). Nomination papers shall be filed at designated places and before the Officers appointed by the Returning Officer for the purpose.
2	The nomination papers shall be scrutinized;	On 6th June, 2017 (From 10.00 am onwards)
3	A candidate may withdraw his candidature;	On 8th June, 2017 (Before 3.00 p.m.)
4	The list of contesting candidates alongwith their photograph showing the name of symbols allotted to them immediately after the time of withdrawal is over shall be prepared and affixed;	On 8th June, 2017 Immediately after the time of withdrawal is over.
5	The list of Polling stations shall be pasted ;	On or before 2nd June, 2017.
6	The Poll, if necessary, shall be held from 8.00 AM to 4.00 PM	On 16th June, 2017
7	Counting of votes, in the event of poll, shall be done	On 17th June, 2017 at 9.00 a.m. at District Headquarters Shimla.

Note: The process of election shall be completed by 17th June, 2017.


