## **NOTIFICATION**

Whereas the State Election Commission has issued election programme vide Notification No.SEC(F)2-6/ 2020- No.SEC(F)2/2020 and dated 13.03.2021 to conduct general elections to four Municipal Corporations Dharamshala, Palampur, Mandi and Solan and six Nagar Panchayats Chirgaon and Nerwa district Shimla, Ani and Nirmand district Kullu, Kandaghat district Solan and Amb district Una.

Therefore, the State Election Commission in exercise of the powers vested in it under Article 243-ZA of the Constitution of India, Section 9 of HP Municipal Corporation Act, 1994 and Section 281 of the Himachal Pradesh Municipal Act, 1994, hereby directs that the Model Code of Conduct as notified by this Commission vide Notification No.SEC-16-29/2000-I-3768 dated 03<sup>rd</sup> November, 2020, shall come into force with immediate effect in the territorial jurisdiction of the abovementioned Municipal Corporations and Nagar Panchayats, till the election process is over.
