## **NOTIFICATION**

Whereas the State Election Commission had issued programme for the preparation of electoral rolls of Municipal Corporation Dharamshala vide its Notification No. SEC-13-7/2-15-415 dated 5<sup>th</sup> January, 2016;

And whereas, the period for filing of claims and objections is fixed as 12.1.16 to 21.1.2016 and the final publication of electoral rolls was fixed on or before  $6^{th}$  February, 2016;

And whereas, the District Election Officer (Municipalities)-cum-Deputy Commissioner Kangra vide letter No. UDB (PA to DC)-5 dated 16.1.2016 has informed that the Revising Authority needs 2 weeks more time to correct the draft voter list and accommodate large number of left out electors;

1.	Draft publication of electoral rolls	27.1.2016
2.	Period for filing claims and objections before the Revising Authority	28.1.2016 to 6.2.2016
3.	Period for deciding claims and objections by the Revising Authority	Up to 12.2.2016
4.	Period for filing appeals before the Electoral Roll Registration Officer	Within three days from the order passed by the Revising Authority i.e. upto 17.2.2016
5.	Period for deciding appeals by the Electoral Roll Registration Officer	Up to 23.2.2016
6.	Final publication of electoral rolls	On or before 25.2.2016



As soon as the notice of final publication is issued by the Electoral Roll Registration Officer, the intimation of the same may be sent to the Commission immediately through E-mail followed by confirmation by post, so that Commission could provide the data of electoral rolls to the printer for printing of these rolls. In all, twenty five sets of electoral rolls in respect of every ward shall be printed. These copies shall be used in the ensuing elections. Rest of the instructions issued vide Notification dated 5.1.2016 shall be adhered to strictly wherever, applicable.
