

| 2 | The nomination papers shall be scrutinized;  | <b>On 9<sup>th</sup> March, 2016, (From 10.00 am onwards)</b>   |
| 3 | A candidate may withdraw his candidature;  | <b>On 11<sup>th</sup> March, 2016 (Between 10.00 am to 3.00 p.m.)</b>   |
| 4 | The list of contesting candidates showing the name of symbols allotted to them immediately after the time of withdrawal is over shall be prepared and affixed; | <b>On 11<sup>th</sup> March, 2016 immediately after the time of withdrawal is over.</b>   |
| 5 | The list of Polling stations shall be pasted ;   | <b>On or before 4<sup>th</sup> March, 2016.</b>   |
| 6 | The Poll, if necessary, shall be held from <b>7.00 AM to 3.00 PM</b>   | <b>On 27<sup>th</sup> March, 2016</b>   |
| 7 | Counting of votes, in the event of poll, shall be done   | <b>The Counting of votes shall be taken up immediately after the close of the poll at the Municipal Headquarters</b>  |


