3	A candidate may withdraw his candidature;	On 11 th March, 2016 (Between 10.00 am to 3.00 p.m.)
4	The list of contesting candidates showing the name of symbols allotted to them immediately after the time of withdrawal is over shall be prepared and affixed;	On 11 th March, 2016 immediately after the time of withdrawal is over.
5	The list of Polling stations shall be pasted;	On or before 4 th March, 2016.
6	The Poll, if necessary, shall be held from 7.00 AM to 3.00 PM	On 27 th March, 2016
7	Counting of votes, in the event of poll, shall be done	The Counting of votes shall be taken up immediately after the close of the poll at the Municipal Headquarters
