NOTIFICATION

Whereas the State Election Commission Himachal Pradesh has issued updation of electoral rolls programme with 01.01.2020 as qualifying date to determine the eligibility of an elector to be registered in the electoral rolls of Panchayati Raj Institutions and Urban Local Bodies in the State vide Notification No. SEC(F)1-PRIs-1/19-2629 dated 28.09.2020;

And whereas the State Election Commission in its review meeting held on 07.10.2020 considered this issue at length and in order to ensure that maximum citizen are provided right to franchise, it was deemed necessary to modify the aforesaid date of eligibility of an elector to be registered in the electoral rolls;

Therefore, in exercise of powers vested in it under Rule 14(e) of the HP Panchayati Raj (Elections) Rules, 1994, Rule 17 (a) of the HP Municipal Election Rules, 2015 and Rule 16(1)(e) of the HP Municipal Corporation Election Rules, 2012 the State Election Commission Himachal Pradesh hereby notifies the First December, 2020 as qualifying date to determine the eligibility of an elector to be registered in the electoral rolls of Panchayati Raj Institutions and Urban Local Bodies in the State of Himachal Pradesh for the ensuing General Elections.

Further the words "the First January, 2020" appearing in para 5 (below the programme table) of the Notification No. SEC(F)1-PRIs-1/19-2629 dated 28.09.2020 is hereby modified to this extent.
