2	The nomination papers shall be scrutinized;	On 4 th June, 2016 (From 10.00 am onwards)
3	A candidate may withdraw his candidature;	On 6 th June, 2016 (Between 10.00 am to 3.00 p.m.)
4	The list of contesting candidates showing the name of symbols allotted to them immediately after the time of withdrawal is over shall be prepared and affixed;	On 6 th June, 2016 immediately after the time of withdrawal is over.
5	The list of Polling stations shall be pasted;	On or before Ist June, 2016.



6	The Poll, if necessary, shall be held from <u>7AM to</u> <u>3 PM</u>	On 17 th June, 2016
7		The Counting of votes shall be taken up immediately after the close of the poll at the Municipal Headquarters
