### **NOTIFICATION**

In exercise of the powers vested in it under Article 243-ZA of the Constitution of India, Section 9 of the Himachal Pradesh Municipal Corporation Act, 1994 read with Rule 24 of the Himachal Pradesh Municipal Corporation Election Rules, 2012, the State Election Commission Himachal Pradesh hereby directs a special revision of electoral rolls of Ward No. 24 -Sangti of Municipal Corporation Shimla, Himachal Pradesh. The date of determining the eligibility of a person for inclusion of the name in the electoral rolls of the said ward shall be 01.01.2018 as required under Rule 16(1) (e) of the Rules ibid.

The Electoral Registration Officer will appoint Revising Authority as required under Rule 19 of the Rules ibid and ensure that wide publicity of the said appointment and of the special revision proramme is made in the said ward.

After the disposal of appeals, if any, Electoral Registration Officer will prepare a supplementary list and attach the same with the final electoral rolls already published on 27.06.2018. The Sr. No. of electors in the supplementary list shall start next to the last Sr. No. of the final electoral rolls. Separate supplementary list shall be prepared for addition, deletion and correction. Even if there is no addition, deletion and correction, a supplement showing nil addition, deletion and correction as the case may be, shall be

attached to the main electoral rolls. The special revision shall be done manually and no exercise shall be undertaken on the ERMS software.

The Electoral Registration Officer will print as many copies of the electoral rolls of the ward as required and ensure that supplementary list prepared for each polling station are attached to the final electoral rolls of the relevant polling station. The supplementary list will be prepared on the following format:-
