## Notification

Whereas, the Election Commission of India has updated electoral rolls of Assembly Constituencies in the State w.e.f. 1.1.2016 as qualifying date;

And whereas, the State Election Commission has also decided to update the electoral roll of all Municipalities in Himachal Pradesh by using the incremental data base of the Election Commission of India;

Consequently, the State Election Commission do hereby notifies 1.1.2016 as qualifying date to determine the eligibility of a person to be registered in the electoral roll of a Municipality under Rule 16 (1) (e) of the HP Municipal Corporation Election Rules, 2012 and Rule 17 (a) of the Himachal Pradesh Municipal Election Rules, 2015.

Further, the Commission in exercise of the powers vested in it under Article 243-ZA of the Constitution of India, Section 281 of the Himachal Pradesh Municipal Act, 1994 read with Rule 14 & 26 of the Himachal Pradesh Municipal Election Rules, 2015 and Section 9 of the HP Municipal Corporation Act, 1994 read with Rule 14 and 24 of the HP Municipal Corporation Election Rules, 2012 do hereby directs the special revision of electoral rolls of all the Municipalities as per programme given below:

1.	Draft publication of electoral rolls	27-4-2016
2.	Period for filing claims and objections	28-4-2016 to 7-05-2016
	before the Revising Authority	



3.	Period for deciding claims and objections by the Revising Authority	Within five days from the filing of claims or objections
4.	Period for filing appeals before the District Election Officer (Panchayats)	Within seven days from the order passed by the Revising Authority
5.	Period for deciding appeals by the District Election Officer (Panchayats)	Within three days from the filing of appeal
6	Final publication of electoral rolls	On or before 25th May, 2016

The claims, objections and appeals shall be received and decided even on holidays. Claims and Objections shall not be received from an individual in bulk. Any person aggrieved by the orders passed by the Revising Authority may file an appeal to the Electoral Registration Officer (Municipalities) (Deputy Commissioner) within seven days from the date of passing of the orders by the Revising Authority. The Registration Officer (Municipalities) will decide the appeal within three days.

After, all the claims / objections and appeals received during the period have been decided, the Electoral Registration Officer (Municipalities) shall cause the draft electoral rolls to be corrected through ERMS software and issue notice of final publication of electoral rolls on the relevant form. The finally published electoral rolls shall be uploaded on the official website.

As soon as the notice of final publication is issued by the Registration Officer, the intimation of the same may be sent to the Commission immediately. The Electoral Registration Officer will print only one copy of electoral roll in respect of every Municipality for inspection by the general public at Municipal Headquarter. Besides, the finally published electoral roll in respect of every Municipality shall be kept in form of soft copy in computer hard disk as well as in CD.

The copies of the electoral rolls be made available for sale at the cost of Rs.10/- per page to be paid in cash against receipt. However a person interested in purchasing of electoral roll shall have to purchase full set of a ward of the concerned Municipality.



The relevant provisions of Rules enshrined under HP Municipal Corporation Election Rules, 2012 and HP Municipal Election Rules 2015 shall be adhered to strictly for the preparation of the said electoral rolls. Needless to say that the aforesaid programmed should be implemented in letter and spirit. If any violation of this programme is noticed, it will be in contravention to the mandate of the Constitution of India and the relevant statutory provisions, which may lead to serious consequences.
