Updation of Electoral Rolls of Panchayati Raj Institutions and Urban Local

Bodies as on 01.01.2016.

Madam / Sir,

1. In continuation of letter No. SEC-16-36/2001-VII-7719-7874 dated 2^{nd} April, 2016, the working copy of the draft electoral rolls in respect of each Panchayat / Municipality has been made available on line through ERMS Software in two parts. The composition of two parts is as follows:

Part-I:-

a.

It consists of already published electoral rolls which have been finalized during recent elections. The electors in this list have already been segregated into concerned wards. Hence Part-I is ward-wise in respect of each Panchayat /Municipality. The names in this part appear House number wise. To avoid loss of data or other eventuality during working on the Part-I, it is required to keep backup of the original date data in CDs / or pen drives as soft copy.



Part-II:-

- a. This part consists of new electors, who have been registered by the Election Commission of India as on 1.1.2016 as qualifying date. These electors have not yet been segregated ward-wise. All new electors have been marked as "नया".
- b. This part also includes those electors of Part-I who are:
 - i. without EPIC No. or Photograph;
 - ii. Modified electors (marked as "संशोधित" in Part-I);
 - iii. Shifted electors (marked as "स्थानान्त्रित" in Part-I).

The existing Ward and Serial Number in Part-I of electors falling in all of the above 3 categories has also been shown with each elector.

- c. The electors in Part-II have been depicted Municipality / Panchayat / Revenue Village- wise. These rolls are in alphabetical order (वर्णाकमानुसार). This brings multiple entries of an elector together in order to check dual registration.
 - 2. The Sub-Divisional Officer (Civil) and Assistant Electoral Roll Registration Officer (AERO) i.e. Block Development Officer as the case may be, will print a copy of Part-II of the working copy of the electoral rolls immediately and hand over these copies to the respective Executive Officer / Secretary Nagar Panchayat and Panchayat Secretary (or GPVA or Panchayat Sahayak) as the case may be for verification, segregation and further processing

Exercise to be undertaken in Part-I

- 3. The EO/Secretary Nagar Panchayar/Panchayat Secretary will check the Part-I of working copies of electoral rolls of every ward and compare these working copies with already finalized and published electoral rolls and ascertain that number of electors in each ward are correct. He will certify that he has checked the Part-I of the working rolls in respect of every ward and verify that:
 - (a) He has checked the working copy of the draft electoral rolls in respect of each ward with previously notified electoral roll.



- (b) That electors are appearing in the concerned Block / Panchayat /ULB / Ward. If there are any discrepancies in the Part-I of working copies, he will immediately bring this fact to the notice of SDO (C) User / Block User in writing with a copy to the District User. The District User will inform the State User immediately.
- 4. If any elector(s) is (are) appearing in wrong (other) ward / Panchayat/ULB / Development Block, they shall be corrected at the working copy stage by shifting i.e. the shifting of electors will be allowed at working stage too.
- There is possibility of multiple appearances of the name of an elector against single EPIC No. in a Particular Ward. In such cases only one entry will be kept whereas all other shall be deleted.
- 6. If an elector is appearing in more than one ward of a particular Panchayat / Municipality, in such cases a list will be prepared and sent to the SDO (Civil) / AERO. The SDO (Civil) / AERO will issue a notice to the person concerned in Annexure-A to choose one ward of a Panchayat / Municipality. Thereafter, the name of that person shall be deleted by the Sub-Division user / Block User from all other wards except one chosen by the elector. The name shall be deleted after the permission of SDO (Civil) /AERO. An entry to this effect will be made in the ERMS indicating permission number and date.
- 7. If it comes to the notice that the name of an elector is appearing in more than one Panchayat / Municipality or simultaneously in a Panchayat and Municipality his name shall be deleted from all the Panchayats / Municipalities except one by serving him notice by the SDO (Civil) / AERO on <u>Annexure-A</u> and directing him to choose only one Panchayat or Municipality.
- 8. If dead electors are appearing in the Part-I, a list of such electors shall be prepared and the name of such electors shall be deleted with the permission of AERO indicating permission number and date and an entry to this effect will be made in the ERMS.



- The deletion of electors at working stage will be allowed only in the case of dead electors and multiple entries with the permission of AERO. No other elector is allowed to be deleted at working stage.
- 10. If it is found that electors in a Ward or Panchayat are considerably higher or reduced, the Panchayat Secretary will enquire from their counterparts in the adjoining Panchayats or Municipalities as the case may be. If these electors are detected in some other Wards / Panchayats or Municipality, the Panchayat Secretary will bring this fact into the notice of AERO and seek his permission who will cause these electors to be shifted to the concerned Panchayat or Municipality indicating permission number in the ERMS Software. In such cases the Block User will make a continuous liaison with the District User (ULB).
- 11. If correct Municipality or Panchayat of extra electors is not identified, the Block User will forward these electors to District User (PRI) certifying that these electors do not belong to that Block. <u>In no circumstances any of such electors</u> shall be deleted, repeat, no such elector shall be deleted.
- 12. The District User (PRI) will enquire from all other Block Users and District User (ULB) about such electors. If any of the Block User or District User (ULB) accepts these electors they will be shifted to that Block / ULB by the District User; otherwise the District Users will shift these electors to State User certifying that these electors do not belong to that District. Shifting of the electors from a Panchayat to ULB or ULB to Panchayat will be done by the District Users with whom the extra electors are appearing with the permission of District Election officer / Deputy Commissioner as the case may be.
- 13. The State User will enquire from all District Users (PRI /ULB) about such electors and if any District User accepts these electors they will be shifted to the concerned District otherwise such electors will be kept as floating data in a folder.



- 14. The EO / Secretary Nagar Panchayat /Panchayat Secretaries of every Municipality / Panchayat shall certify in Annexure-B that he has compared Part-I of the working copies with the previously finalized and published Electoral Roll and no discrepancy have been found or the discrepancies, if found, have been corrected.
- 15. The SDO (Civil) / Assistant Electoral Roll Registration Officer (BDO) will print only one copy of part-II of the electoral rolls of each Municipality / Panchayat and hand them over to the respective EO / Secretary Nagar Panchayat /Panchayat Secretaries on the same day. All work pertaining to Part-II shall be completed by 16th April, 2016.

Exercise to be undertaken in Part-II

- 16. The Assistant Electoral Roll Registration Officer will get the physical verification of new electors appearing in Part-II done through the concerned Panchayat Secretary by house to house visit. The Secretary will insert the ward number of new electors so that the electors without wards could be mapped for wards through ERMS. The objective of this exercise will be as under:
 - To integrate the electors of part-II with the main electoral rolls i.e. part-I after physical field verification and ward-wise segregation thereof for new/modified/shifted electors.
 - Entry of EPIC No. of electors who are appearing in Part-I without EPIC Number (existing Ward and Sr. No. in Part-I of such electors will be shown in Part-II also).
 - iii. Insertion of Photograph of those electors of Part-I who are appearing in Part-I without photograph. (existing Ward and Sr. No. in Part-I of such electors will be shown in Part-II also).
- 17. The list of voters appearing in part-II will have two blank columns to enter ward Number and name of Panchayat /ULB (In case the elector is appearing in incorrect Panchayat /ULB).



- 18. The Panchayat Secretary will verify that the electors appearing in Part-II reside in the respective Panchayat ward.
- 19. The electors who are without EPIC Number, however verified and are still residing in the concerned ward, will be asked whether or not they have been registered with ECI. In case of affirmative response, their EPIC number will be obtained and noted.
- 20. If any new (नया), modified (संशोधित) or shifted (स्थानान्त्रित)electors appearing in Part-II are not verified, the Panchayat Secretary will prepare a list of such electors on *Annexure-C* and supply this list to the SDO (Civil) / AERO, who will cause this list to be published at the notice board of Block Headquarters and Panchayat Headquarters for the information of general public.
- 21. If any unverified elector is verified after publication of such list on the Notice Board his name shall be mapped in the respective ward otherwise such names will be retained in the list of unused electors.
- 22. The electors who are without photograph and still not registered with the ECI but residing in the same area their photo will be obtained for being scanned at Sub-Division/ Block Headquarter in order to insert the same in the electoral roll.
- 23. The work pertaining to verification shall be completed by 22rd April, 2016.

Integration of Part-I and Part-II

- 24. After verification exercise, data entry work including the integration of part-I and Part-II will be undertaken simultaneously and should be completed on or before by w.e.f. 26th April, 2016 at Block Headquarters through ERMS software for which user ID and user manual have already been provided to you. If, for any reasons, this work cannot be handled at Block Headquarter it can be done at District Headquarters at the discretion of District Election Officer (Panchayat) –cum- Deputy Commissioner concerned.
- 25. No addition, deletion or correction (except for deletion in case of death, multiple entries and modification in case of EPIC number Photograph is



- missing) shall be allowed at the working stage. The Commission shall notify a separate programme for this exercise as per relevant Election Rules.
- 26. The EO / Secretary (Municipality) /Panchayat Secretary will submit a certificate, annexed as Annexure-D, in writing to the SDO (Civil) / Assistant Electoral Roll Registration Officer (BDO). This Certificate shall be countersigned by the respective Panchayat Inspector / Sub-Inspector in respect of Panchayats.
- 27. The SDO (Civil) / Assistant Electoral Roll Registration Officer (BDO) will further issue a certificate to the Deputy Commissioner, annexed as Annexure-E
- 28. The dates for shifting of stage of working copy of the electoral roll to Draft Electoral Roll shall be intimated by the Commission. The District Election Officer (Panchayat)-cum- The Deputy Commissioner shall allow to shift the stage of a Panchayat only if certificate mentioned above has been obtained from the Assistant Electoral Roll Registration Officer (BDO).
- 29. The required stationary for printing CDs etc. will be procured by the AERO from local market after completing formalities, the bills of the same may be sent to District Election Officer (P) (Deputy Commissioner).
