And whereas the State Election Commission has decided to proceed for delimitation of wards of Municipal Corporation Shimla on the basis of population as ascertained during Census 2011 in accordance with Section 2(38) of the Himachal Pradesh Municipal Corporation Act, 1994;

Now therefore, the State Election Commission, Himachal Pradesh in exercise of the powers vested in it under Article 243 ZA of the Constitution of India, Section 9 (1) of the Himachal Pradesh Municipal Corporation Act, 1994 read with Rule 6(1) and 10 of the Himachal Pradesh Municipal Corporation Election Rules, 2012, hereby directs that the delimitation of wards in Municipal Corporation Shimla shall be undertaken as per following programme:-
