Whereas the General Elections to Municipal Corporation Shimla were conducted on 27 May,2012 in accordance with the wards delimited during the year 2007 on the basis of Census, 2001 and the term of present Municipal Corporation Shimla is going to expire on 5th June, 2017;

And whereas the Census 2011 has been completed and the Registrar General of Census Operations has published the population figures;

And whereas the State Election Commission has decided to proceed for delimitation of wards of Municipal Corporation Shimla on the basis of population as ascertained during Census 2011 in accordance with Section 2(38) of the Himachal Pradesh Municipal Corporation Act,1994;

Now therefore, the State Election Commission, Himachal Pradesh in exercise of the powers vested in it under Article 243 ZA of the Constitution of India, Section 9 (1) of the Himachal Pradesh Municipal Corporation Act, 1994 read with Rule 6(1) and 10 of the Himachal Pradesh Municipal Corporation Election Rules, 2012, hereby directs that the delimitation of wards in Municipal Corporation Shimla shall be undertaken as per following programme:-



1.	Publication of Draft Proposal of the delimitation of wards	24.10.2016
2.	Filing of objections on the draft proposal by the residents of Municipal areas before the Deputy Commissioner Shimla	25.10.2016 to 03.11.2016
3.	Disposal of suggestions or objections by the Deputy Commissioner	Within ten days from the receipt of objections
4.	Filing of Appeals against the order of Deputy Commissioner before the Divisional Commissioner Shimla	Within ten days from the disposal of objections

5.	Disposal of Appeals by the Divisional Commissioner	Within ten days from the filing of Appeals
6.	Final orders of Delimitation of Wards by Deputy Commissioner Shimla	On or before 6th. December, 2016
