List of district wise ballot papers and other material will be handed over to your official/ representative at the time of delivery of material. Necessary entries of the material may also be ensured in your office record please. Loading charges of material including gunny bags will be borne by this Office.

The material going to be delivered includes ballot papers therefore, tight security is desired during transit and storage of above material. Sufficient number of security personnel be deployed for this purpose at all places right from receiving the material in the premises of H.P.Printing Press Ghoda Chowki till its use in election process. The vehicles deployed for this purpose should have proper arrangements of covering roof to avoid any damage to the material due to rain or other weather calamities. It is also requested to arrange and bring metal/wooden/cardboard boxes, if available, for carrying ballot papers.
