NOTIFICATION

Whereas the State Election Commission has issued programme for preparation of electoral rolls of Municipal Corporation Shimla for the ensuing elections to Municipal Corporation Shimla and today i.e. 16th March 2023 is the last date fixed for filing of claims and objections;

And whereas Government of Himachal Pradesh Department of Urban Development has amended Rules 14, 16, 26 and Form-4 of the HP Municipal Corporation Election Rules, 2012 vide Notification No. UD-A(3)-2/2020 dated 14.03.2023;

And whereas the Deputy Commissioner Shimla vide letter No.SML-LFA-ERMS(MC)/2022-333 dated 16.03.2023 has requested this Commission to extend the last date fixed for filing of claims and objections in view of change in the relevant rules;

And whereas the matter was examined in the Commission at length and the Commission is of the considered view that in order to provide opportunity to eligible electors to enroll their names in the electoral rolls of the relevant wards of the Municipal Corporation Shimla and in the interest of larger participation of the voters in democratic process, it will be appropriate to revise the programme for preparation of electoral rolls of Municipal Corporation Shimla;

Therefore, the State Election Commission in exercise of the powers vested in it under Article 243ZA of the Constitution of India, Section 9 of the HP Municipal Corporation Act, 1994 read with Rule 14 of HP Municipal Corporation Election Rules, 2012 hereby issues the revised schedule for preparation of polling station wise electoral rolls of Municipal Corporation Shimla as under: -

1	Period for filing claims and objections before Revising Authorities	Upto 20.03.2023
2	Period for deciding claims and objections by Revising Authorities	By 27.03.2023
3	Period for filing appeals before the concerned Electoral Registration Officer	Within 3 days of passing of order by Revising Authority i.e. upto 31.03.2023
4	Period for deciding appeals by the concerned Electoral Registration Officer	By 04.04.2023
5	Final Publication of electoral rolls	06.04.2023

The Commission further directs that the claims /objections/appeals and disposal thereof shall be undertaken even on holidays in public interest.
