Subject :-

Lump-sum payment to the staff deputed on election duty in lieu of Travelling Expenses.

Madam/Sir,

As you are aware that the general elections to Panchayati Raj Institutions are due in this year. In these elections thousands of employees are deputed on election duty. After the conduct of elections, these employees submit T.A. claims through their Head of Offices. Thereafter, these bills are sent to the B.D.O's after verification of basic pay, which are further sent to the respective District Panchayat Officers for payment. In order to simplify the procedures and to save the resources of the Government such as manpower, stationery, postage and duplication of efforts and for early disbursement of claims, the State Election Commission had taken up the matter with Finance Department to pay lump-sum amount to the staff deputed on election duty in lieu of Travelling Expenses.

Now the Finance Department has approved following rates to pay a lump-sum amount to the staff deputed on election duty in lieu of Travelling Expenses.:-

Keeping in view the above decision, the Block Development Officer while requisitioning the staff for election duty will also procure information with regard to bank details from the concerned official on the annexure enclosed herewith. The details mentioned in annexure are not exhaustive and the District Election Officer (Panchayat) and Block Development Officer may also seek any additional information which may help them to keep the accounts of lump-sum payment in transparent and convenient manner. After compiling all the claims the Block Development Officer will forward the claims to District Election Officer (P) so that lump-sum amount may be deposited in the account of the official deputed on election duty or kept as reserve staff. In case, where an official deputed on election duty is relieved in middle of the election duty due to unavoidable circumstances he will be paid proportionate payment.
