Subject: - Verification of households and mapping of electors of newly created and re-organised Panchayats.

Madam/Sir

As you are aware that more than 400 Gram Panchayats have been created in Himachal Pradesh and stand finally notified by the Panchayati Raj Department. In most of the newly created/ re-organized Panchayats, delimitation of wards has been completed or will be completed shortly. The new Panchayats are to be constituted before 23rd January, 2021.

Therefore, due to time constraints, the Commission has decided to start identification of households and mapping of electors in the respective wards of the Panchayats newly created or effected by re-organisation process. The process will be carried out through ERMS Software without waiting for final orders of delimitation of wards wherever applicable. In order to undertake this work, the re-organised /newly created Panchayats are required to be updated on the ERMS Software as per notification issued by the Panchayati Raj Department.


Hence, the Commission has decided to issue the following schedule for the above mentioned exercise;

S. No.	Exercise to be undertaken	Date
1.	Identification of households included in the particular ward	Upto 24 th October, 2020
2.	Creation of New Panchayats/Wards of newly created and reorganised Panchayats along with updation of the extent of wards thereof.	Upto 28 th October, 2020
3.	Mapping and shifting of electors	Upto 30 th October, 2020
4.	Generation of preview copy and printing of preview draft roll	Upto 3 rd November, 2020
5.	Meeting of the Panchayats to discuss the preview draft roll	5 th November, 2020
6.	Correction in the working copy pointed out during the above said Panchayat meeting if required, and shifting of stage and printing of five copies of the draft voter list.	Upto 7 th November, 2020

The preview of the draft electoral rolls shall be placed before the existing Panchayats (undivided) in order to ascertain the accuracy of newly created wards and electors mapped therein. If more than one Panchayats are involved in the creation of a new Panchayat, preview copy should be placed before all the concerned Panchayats.

The Commission is contemplating to publish draft Electoral Roll of these newly created/ re-organised Panchayats on 9th November, 2020. Therefore, I am directed to request you to ensure that the above mentioned schedule is adhered to strictly to enable the Commission to hold the election within stipulated time.


