Orders issued by the Hon'ble High Court in CWP NO. 1391 & 1442 of 2022- Updation of Electoral Rolls of Municipal **Corporation thereof.**

Sir,

As you are aware that Hon'ble High Court of Himachal Pradesh while disposing of the CWPs 1391of 2022 and 1442 of 2022 has directed to decide the objections moved by the Petitioners afresh in respect of Wards Nabha and Summerhill. Therefore, you are requested to hear and dispose of the objections of the petitioners expeditiously in pursuance to the orders of the Hon'ble High Court.

Besides, with the disposal of these petitions the status quo maintained by the Hon'ble High Court has also come to an end. Therefore, I am directed to request you to fix the polling stations in the wards and publish the list of polling stations in respect of remaining 36 wards (except for those wards which are involved in process for hearing of objections in pursuance to the orders of the Hon'ble High Court) and start mapping of polling stations, sections and electors as per schedule given below:-

3.	Mapping of Sections by Block User	Up to 13.06.2022
4.	Verification of Electors	Up to 22.06.2022
5.	Mapping of electors of Part-II	Up to 25.06.2022

The list of polling stations in respect of Nabha, Summerhill and other connected wards shall be published as soon as the delimitation of wards in respect of these wards is finally notified in pursuance to the orders of the Hon'ble Court. You are requested to ensure completion of the updation work within the specified time. Detailed instructions/guidelines for preparation of draft electoral rolls are being issued separately. Besides all protocol fixed in view of Covid-19 Pandemic may be adhered to strictly while undertaking the said work.
