**NOTIFICATION**

Whereas the State Election Commission Himachal Pradesh has issued programme for updation of electoral rolls of five wards viz. 6-Summerhill, 9-Boilgeauganj, 11-Tutikandi, 12-Nabha and 13 Phagli vide Notification No. State Election Commission Himachal Pradesh(F)1-28/2021-2204 dated 08.07.2022;

And whereas two CWPs No. 4574 of 2022 and 4579 of 2022 were filed before the Hon'ble Court wherein delimitation of abovementioned five wards has been challenged;

And whereas the Hon'ble High Court of Himachal Pradesh, while hearing CWPs No. 4574 of 2022 and 4579 of 2022, has granted stay on the order the Deputy Commissioner dated 24.06.2022 and Divisional Commissioner dated 08.07.2022;

Therefore the State Election Commission Himachal Pradesh in pursuance to the order passed by the Hon'ble High Court in abovementioned CWPs hereby orders to maintain the status quo on date till further orders.

Further the State Election Commission hereby directs that all the claims/objections/corrections received in respect of these wards may be kept pending in safe custody of Electoral Registration Officer till further orders.


